In order to qualify for the SILK Laser Clinics Fashions on the Field Final held at Fannie Bay Racecourse on Monday 6<sup>th</sup> August, individuals must compete and be successful in one of the nominated heats throughout the Carnival.

### **JUDGING CRITERIA**

Contestants will be judged following the following criteria:

- Style and originality;
- Appropriateness of the outfit for the specific race day and the individual;
- Attention to detail with accessories;
- Understanding and interpretation of the current fashion trends / or understanding and interpretation of the Carnival of Colour theme; and
- Grooming and deportment.

### **ENTRY CONDITIONS**

- By participating in either the Heats or Final, contestants agree to observe and be bound by these Terms & Conditions.
- The women's race wear category heats will consist of 6 events held at the Darwin Turf Club
  - Day 3 - Ladies Day Wednesday 18<sup>th</sup> July: x4 competitions x2 on track and x2 in Schweppes Pavilion Ladies Luncheon event. Contestants may register for either competition but not both.
  - Day 4 - Derby Day Saturday 21<sup>st</sup> July: x1 competition on track
  - Day 7 - Sprint Day Saturday 4<sup>th</sup> August: x1 competition on track
  - Day 8 - Darwin Cup Day Monday 6<sup>th</sup> August: x2 competitions on track (Under 40, Over 40, Men's, Millinery)
  - Race wear & Millinery Final – Darwin Cup Monday 6<sup>th</sup> August
- Pre-registrations are limited to 20 places on Days 3, 4 and 7.
- Day 8 pre-registrations are limited to 60 people with pre-judging rounds held before successful nominations announced for the 20 entrants for the Under 40 and Over 40 category heats.

- By nominating for SILK Laser Clinics Fashions on the Field you consent to having your photo/video taken to be used/broadcast by attending media, the Darwin Turf Club and by Victoria Racing Club Limited for marketing and promotional purposes.
- DTC will advise the Finalists of competition judging times and finalists who fail to appear at the correct time will be disqualified from the final and their entry deemed invalid.
- The judges will determine the winners of the 2018 SILK Laser Clinics Fashions on the Field heats and final in accordance with the judging criteria.
- The winner of each minor competition pre Cup Day will progress to the final on Carlton Mid Darwin Cup Day on Day 8.
- On Day 8 Darwin Cup Day, two finalists from the Under 40 and Over 40 female categories will progress to the grand final held later that day.
- 8 female finalists in total will compete in the Grand Final with a winner and runner up being announced by the panel of judges.

#### HOW TO ENTER

- In order to qualify for the SILK Laser Clinics Fashions on the Field Final, contestants must compete and be successful at one of the nominated Heats.
- To enter one of the heats you must register on the day at the Fashions on the Field area by completing the entry form provided during the registration period.
- Contestants may enter once per heat provided that:
  - A contestant may not compete in the same outfit for each heat (to avoid doubt, an outfit worn in one heat and altered for a second heat will be disqualified)
  - A contestant has not already won a heat
- No responsibility will be taken to incomplete, late or lost entries or if the contestant is late to register.

## **ELIGIBILITY**

To be eligible to participate in the Fashions on the Field competition, contestants must acknowledge and agree to the following contestant criteria (Contestant Criteria):

- Contestants must be 18 years of age or older.
- Contestants and/or their outfits must not promote commercially a brand, store or designer or receive a commercial benefit from appearing in the competition.
- Contestants must not alter or add to their outfit in any way from the beginning until the end of the Competition. (Including Heats and Finals)
- Entry may be refused if a Contestant does not meet one or more of the Contestant Criteria listed.
- DTC reserves the right to verify the validity of any entries and reserves the right to disqualify any entrant who supplies invalid information that is not in accordance with these Terms & Conditions.

## **TERMS & CONDITIONS**

- The judging panel's decision is final.
- In the event of a draw at the Heat and or Final, the head judge will determine the winner.

## **HEAT PROCESS**

- The 2018 SILK Laser Clinics Fashions on the Field Heats will be conducted over four race meetings.
- A contestant who wins a heat is not eligible to qualify at any other heat throughout the series.
- A contestant who wins a Heat and qualifies for the Final may make further alterations or additions to their outfit or create an entirely new outfit for the Final.

- Two contestants from the Under 40 heat and the Over 40 heat on Darwin Cup Day will go through to the Grand Final in no particular order.
- The winner of each Heat will be required to attend Cup Day on Monday 6<sup>th</sup> August to compete in the Grand Final.

#### FINAL PROCESS

- The Heat winners will compete in the 2018 SILK Laser Clinics Fashions on the Field Grand Final on Monday 6<sup>th</sup> August 2018.
- The finalists will consist of eight valid winners from the heats conducted throughout the Carnival.

#### WINNERS & COMPETITION PRIZES
